

December 27, 1944

A call meeting of the Town Council of the Town of Wilsonville, Alabama, was held in the Mayor's office on Wednesday evening, December 27, 1944, and there were present E. B. Lindsey, Mayor, and the following Councilmen: D. F. Bolton, Carlton Franks, J. C. Roper, R. R. Roberson, and Arthur Mooney.

Thereupon Councilman, R. R. Roberson introduced the following ordinance:

ORDINANCE 1A

To be entitled "An ordinance to levy a tax upon all property and all subjects of taxation liable therefor within the corporate limits of the Town of Wilsonville, Alabama, for the present year, upon assessments to be made by Luther Fowler, made or based upon the State assessments upon the property situated in said Town as assessed for State taxation during the preceding year, and to fix the rate of said taxation."

Be it ordained by the Town Council of the Town of Wilsonville, Alabama, as follows:

SECTION ONE: For the purpose of meeting the legal obligations and current expenses of the Town of Wilsonville, Alabama, for the present year, a tax of one half of one per centum is hereby levied upon all property and all subjects of taxation liable therefor within the corporate limits of the Town of Wilsonville, Alabama, upon assessments to be made by Luther Fowler, who is the person designated to make said assessments, said assessments to be made or based on the value of such property as assessed for State taxation during the preceding year.

Thereupon Councilman D. F. Bolton moved that unanimous consent of the Mayor and Council be given for the immediate consideration of an action upon said ordinance, which said motion for unanimous consent was seconded by Councilman Carlton Franks. Thereupon said motion for unanimous consent being submitted to a vote of the Mayor and council, said vote resulted as follows:

AYES: Mayor E. B. Lindsey and Councilmen D. F. Bolton, Carlton Franks, J. C. Roper, R. R. Roberson, and Arthur Mooney

NAYS: None

Thereupon the Mayor, in open council, declared said motion carried and unanimous consent given for the immediate consideration of an action upon said ordinance.

Thereupon Councilman J. C. Roper moved that said ordinance be adopted, which said motion was seconded by Councilman R. R. Roberson.

Thereupon said motion for the adoption of said ordinance being submitted to a vote of the Mayor and Council said vote resulted as follows:

AYES: Mayor E. B. Lindsey and Councilmen D. F. Bolton, Carlton Franks, J. C. Roper, R. R. Roberson, and Arthur Mooney

NAYS: None

Thereupon the Mayor in open council declared said motion carried and said ordinance adopted, it having received the favorable vote of the Mayor and all members of the Council.

ORDINANCE NO. 2A

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WILSONVILLE, ALABAMA AS FOLLOWS:

SECTION ONE: That it shall be unlawful for any person, firm or corporation to drive any motor vehicle recklessly or unsafe speed in the corporate limits of the Town of Wilsonville, Alabama.

SECTION TWO: Any person, firm or corporation violating section one of this ordinance shall, upon the first conviction be fined not more than \$50.00 and for any subsequent conviction, shall be fined not to exceed \$100.00 and may, in the discretion of the court be sentenced to hard labor on the streets of the said Town for a period not to exceed six months; provided that no female shall be required to work on the Town's streets.

SECTION THREE: That the following matters and things be and they are hereby ordained to be unlawful and any person found guilty of any of the matters and things hereinafter set out shall be fined in accordance with the schedule hereinafter set out. Said schedule being as follows:

Drinking while driving ..... \$50.00  
Stop sign, failure to stop at ..... 5.00
