

SECTION NINE. This Ordinance shall be entitled and shall be cited as, "An Ordinance TO CALL A REGULAR MUNICIPAL ELECTION TO BE HELD IN THE TOWN OF WILSONVILLE, ALABAMA, ON MONDAY, SEPTEMBER 15, 1952, FOR THE PURPOSE OF ELECTING A MAYOR AND TOWN COUNCILMEN FOR SAID TOWN."

Said Ordinance was read at length, and thereupon Councilman D. F. Bolton moved that unanimous consent of the Mayor and Council be given for the immediate consideration of, and action upon said Ordinance, which motion was seconded by Councilman J. S. Hill. Said motion for unanimous consent was submitted to a vote of the Mayor and Council and said vote resulted as follows:

A call meeting of the Town Council of the town of Wilsonville, Alabama was held in the Mayor's office on Tuesday evening September 2, 1952 and there were present Mayor Jack Story and Councilmen D. F. Bolton, J. C. Roper, V. J. Fulmer, J. S. Hill, and L. H. Cosper.

Councilman D. F. Bolton introduced the following ordinance:

ORDINANCE 5A

To be entitled "An Ordinance to levy a tax upon all property and all subjects of taxation liable therefor within the corporate limits of the Town of Wilsonville, Alabama, for the present year, upon assessments to be made by Luther Fowler, made or based upon the State assessments upon the property situated in said Town as assessed for State taxation during the preceding year, and to fix the rate of said taxation."

SECTION ONE: For the purpose of meeting the legal obligations and current expenses of the Town of Wilsonville, Alabama, for the present year, beginning October 1, 1952 and ending September 30, 1953, a tax of one half of one per centum is hereby levied upon all property and all subjects of taxation liable therefor within the corporate limits of the Town of Wilsonville, Alabama, upon assessments, to be made by Luther Fowler, who is the person designated to make said assessments to be made or based on the value of such property as assessed for State taxation during the preceding year.

Thereupon Councilman J. S. Hill moved that unanimous consent of the Mayor and Council be given for the immediate consideration of and action upon said ordinance, which said motion for unanimous consent was seconded by Councilman L. H. Cosper. Thereupon said motion for unanimous consent being submitted to a vote of the Mayor and Council, said vote resulted as follows:

ORDINANCE NO. 5A

To Fix A License And Prescribe The Rate Of Such License For The Priviledge Of Persons, Firms And Corporations Engaging In The Business Of Selling Electrical Current Or Energy Outside The Corporate Limits, But Within The Police Jurisdiction Of The Municipality.

BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF WILSONVILLE, ALABAMA, AS FOLLOWS:

SECTION ONE. Each person, firm or corporation engaged in the business of selling electric current or energy outside the corporate limits of the Municipality of Wilsonville, Alabama, but within the police jurisdiction thereof, an amount equal to one and one-half per cent (1 1/2%) of the gross receipts derived during the preceding calendar year from the sale of electrical current or energy to consumers, users, and/or distributors thereof residing or having a place of business outside the corporate limits, but within the police jurisdiction of the Municipality of Wilsonville, Alabama, when such current or energy after sale thereof at any place, is consumed or used outside the corporate limits but within the police jurisdiction, of Wilsonville, Alabama by such consumers or users, or is distributed from any point or points outside the corporate limits out within the police jurisdiction of Wilsonville, Alabama by such distributors.

SECTION TWO. The license tax fixed and prescribed by this ordinance shall be in effect from July 1, 1953.

SECTION THREE. All ordinances, parts of ordinances, or schedules of licenses of the said municipality Wilsonville, Alabama in conflict herewith are hereby expressly repealed.

SPECIAL MEETING OF THE
MAYOR AND TOWN COUNCIL OF THE TOWN OF WILSONVILLE,
ALABAMA, HELD ON 13 DAY OF DECEMBER, 1954

A call meeting of the Town Council of the Town of Wilsonville, Alabama was held at the regular place for holding said Council meetings in Wilsonville, Alabama, on the 13 day of December, 1954, at 7:30 o'clock p.m. and there were present at said meeting the Mayor S. S. McEwen, and the following Councilmen: G. K. Baker, G. W. Rayfield, and V. J. Fulmer, the same constituting a quorum.

Councilman V. J. Fulmer introduced the following ordinance which was read in full and considered:

ORDINANCE NO. 6A

AN ORDINANCE
TO FIX AND PRESCRIBE LICENSE SCHEDULE FOR THE
TOWN OF WILSONVILLE, ALABAMA, AND THE POLICE JURIS-
DICTION THEREOF, UPON THE HERINAFTER ENUMERATED
VOCATIONS, PROFESSIONS, BUSINESSES, TRADES OR
CALLINGS FOR THE YEAR 1955

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF WILSONVILLE, ALABAMA, AS FOLLOWS:

SECTION ONE. That all persons, firms, or corporations who shall engage in or carry on any of the trades, businesses or professions hereinafter prescribed, or who shall keep, carry on or be engaged in keeping or carrying on any of the trades, businesses, professions or establishments, or to do any of the acts hereinafter specified within the corporate limits of the Town of Wilsonville, Alabama, on or after the 1st day of January, 1955, and before January 1, 1956, shall first pay a license tax for the privilege of engaging in or carrying on said trade, business, profession or establishment; or for doing such acts of business within the corporate limits of said Town, and procure a license therefor, such trades, businesses, professions, establishments or acts, and the license therefor shall be as follows:

AUCTIONEERS, transient	\$5.00 per day; per week	\$15.00
AUTOMOBILES, new or used, dealers in, per annum		25.00
AUTOMOBILE REPAIR SHOPS		5.00
AGENTS, each agent or dealer or business for which a specified license is not provided for in this ordinance shall pay as follows:		
(a) Per year		25.00
(b) Per week		10.00
(c) Per day		2.50
AMUSEMENT DEVICES, for each, per week		10.00
AUTOMOBILE ACCESSORIES, each dealer where not in connection with dealer or repair shop		15.00
BANKRUPT SALE OR FIRE STOCK, selling or advertising for sale goods, wares, or merchandise		50.00
