That the said original ordinance entitled "Improvement Ordinance No. 6" heretofore adopted by the Town Council of the Town of Wilsonville, Alabama, at a meeting thereof held on September 6, 1961, be and the same hereby is readopted and in all things ratified and confirmed and the said improvements ordered to be made as therein specified.

SECTION TWO. That this Ordinance is hereby termed and designated and shall be known and may be cited as "Confirmatory Improvement Ordinance Number 6."

SECTION THREE. The Town of Wilsonville, Alabama, having a population of less than 2,000 inhabitants as shown by the last federal census, the Town Council elects to give notice of the passage of this Ordinance by posting notices at three public places within the corporate limits of said Town, one of which shall be posted in front of the Mayor's Office or at the United States Post Office.

Said Ordinance was read at length and thereupon Councilman Lee Reinhardt moved that unanimous consent of the Mayor and Council be given for the immediate consideration of and action upon said Ordinance, which motion was seconded by Councilman B. E. Cunningham. Said motion for unanimous consent was submitted to a vote and said vote resulted as follows:

A CALL MEETING OF THE MAYOR AND
TOWN COUNCIL OF THE TOWN OF WILSONVILLE, ALABAMA

A call meeting of the Mayor and Town Council of the Town of Wilsonville, Alabama, was held in the Town Hall in Wilsonville, Alabama, the regular place for holding meetings of said Council on the 19 day of November, 1962, at 12:30 o'clock p.m. and there were present at said meeting, R. G. Stephenson, Mayor and the following Councilmen: Billy Whatten, Winston Baker, Jimmie Morris, Lee Reinhardt.

Councilman Lee Reinhardt introduced the following Ordinance:

ORDINANCE NO. 18A

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WILSONVILLE, ALABAMA, AS FOLLOWS:

SECTION ONE:

(a) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 40 miles per hour from the City Limits of the town of Wilsonville, Alabama, on Highway 25 going in a westerly direction to its intersection with McGowan Road.

(b) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 25 miles per hour on McGowan Road from its intersection with Alabama Highway 25 going in a westerly direction to its intersection with Blue Springs Road.

(c) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 40 miles per hour on Blue Springs Road from its intersection with Alabama Highway 25 going in a westerly direction to the City Limits of the Town of Wilsonville, Alabama.

(d) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 40 miles per hour on Alabama Highway 25 from its intersection with Blue Springs Road in a westerly direction to the City Limits of Wilsonville, Alabama.

(e) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 40 miles per hour on Lokey's Road from the City Limits of the town of Wilsonville, Alabama, to its intersection with Alabama Highway 25.

(f) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 25 miles per hour on the old Montgomery Road from its intersection with Alabama Highway 25, in a southwesterly direction 2112 feet.

(g) That it shall be unlawful for any persons, firm or corporation to drive any motor vehicle in excess of 40 miles per hour on old Montgomery Road from a point 2112 feet southwesterly from its intersection with Alabama Highway 25 and extending southwesterly to the City Limits of the town of Wilsonville, Alabama.

(h) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 25 miles per hour on Hebb Road, beginning at its intersection with old Montgomery Road and running in a southerly direction 1320 feet.

(i) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 40 miles per hour on Hebb Road from a point 1320 feet from its intersection with old Montgomery Road and running in a southerly direction to the City Limits of the town of Wilsonville, Alabama.

(j) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 40 miles per hour on the Fourmile Road from its intersection with Alabama Highway 25 in a northerly direction to the City Limits of the town of Wilsonville, Alabama.

(k) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 25 miles per hour on Gould Road from its intersection with Alabama Highway 25 in a northerly direction to its intersection with Niven Street.

(l) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 25 miles per hour on Breland Street from its intersection with Brothers Avenue in a northerly direction to its intersection with Kennedy Avenue.

(m) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 25 miles per hour on Mitchell Street from its intersection with Brothers Avenue in a northerly direction to its intersection with Kennedy Avenue.

(n) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 25 miles per hour on McGowan Road from its intersection with Alabama Highway 25 in a southeasterly direction to the City Limits of the town of Wilsonville, Alabama.

(o) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 25 miles per hour on Spearman Avenue from its intersection with Alabama Highway 25 in a southerly direction to its intersection with Hill Street.

(p) That it shall be unlawful for any person firm or corporation to drive any motor vehicle in excess of 25 miles per hour on Oakland Avenue from its intersection with Alabama Highway 25 run in a circular direction around Oakland Avenue until it again intersects the easterly side of Alabama Highway 25.

(q) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 25 miles per hour on Kennedy Avenue from its intersection with Hebb Road in an easterly direction to its intersection with Mitchell Street.

(r) That it shall be unlawful for any person, firm, or corporation to drive any motor vehicle in excess of 25 miles per hour on all other streets, roads, avenues and alleys within the corporate limits of the town of Wilsonville, Alabama.

SECTION TWO: Any person, firm or corporation violating any paragraph of Section One of this Ordinance shall, upon the first conviction be fined not more than \$50.00 and for any subsequent conviction shall be fined not in excess of \$100.00 and may, in the discretion of the court be imprisoned in the jail not to exceed six months, or may be sentenced to hard labor on the streets of said Town for a period not to exceed six months; provided, however, that no female shall be required to work on the Town's streets.

SECTION THREE: That the following matters and things be and they are hereby ordained to be unlawful and any person found guilty of any of the matters and things hereinafter set out shall be fined in accordance with the schedule hereinafter set out. Said schedule being as follows:

SECTION FOUR: In addition to the fines set out in the schedule in Section Three, the court may in its discretion, for any second offense listed above imprison the offender not to exceed six months or sentence him to hard labor on the streets of said Town for a period not to exceed six months; provided, however, that no female shall be required to work on the Town's streets.

SECTION FIVE: That any person found guilty of a misdemeanor committed under the laws of the State of Alabama within the limits of the town of Wilsonville, Alabama, or the police jurisdiction thereof, shall be punished by the Court as is provided by the State law under which the defender is tried.

SECTION SIX: This Ordinance shall become effective upon being signed by the Mayor and being published as provided by law.

SECTION SEVEN: The town of Wilsonville, Alabama, having a population of less than 2,000 inhabitants, as shown by the last federal census, the Town Council elects to give notice of the passage of this Ordinance by posting notices at three public places within the corporate limits of said Town, one of which shall be posted in front of the Mayor's Office or at the United States Post Office.

ADJOURNED REGULAR MEETING
OF THE MAYOR AND TOWN COUNCIL OF THE
TOWN OF WILSONVILLE, ALABAMA, HELD ON
NOVEMBER 5, 1963

The Mayor and Town Council of the Town of Wilsonville, Alabama, met in adjourned regular session at the Town Hall in said Town, which is the usual place of meeting and said Mayor and Council, pursuant to the adjournment of the regular meeting held on November 4, 1963. Upon roll call the following were found to be present: Mayor Stephenson, and the following Councilmen: D. F. Bolton, Lee Reinhardt, Sam Stoudenmire, George Winston Baker and Billy Whitten. J. F. Helms, the Town Clerk, was also present.

The following ordinance was introduced in writing by Councilman Billy Whitten and was read at the meeting:

IMPROVEMENT ORDINANCE NO. 8

AN ORDINANCE TO PROVIDE FOR THE CONSTRUCTION
OF CERTAIN SANITARY SEWERS IN THE TOWN OF
WILSONVILLE, ALABAMA

BE IT ORDAINED, by the Mayor and Town Council of the Town of Wilsonville, Alabama, as follows:

Section 1. Sanitary sewers shall be constructed in the Town of Wilsonville, Alabama, along the following described lines:

(a) Beginning at a point 13 feet from the east edge of the paving of Alabama Highway 25, the said point being 288 feet northeast of the intersection of Main Street with Alabama Highway 25; thence 53° left and westerly a distance of 171 feet to a point on the west edge of the paving of Main Street; thence 96° right and northerly along the west edge of the paving of Main Street a distance of 512 feet;

(b) Beginning at a point 5 feet west of the west edge of the paving of Alabama Highway 25, the said point being 288 feet northeast of the intersection of Main Street and Alabama Highway 25; thence northeasterly along the west edge of the paving of Alabama Highway 25 a distance of 580 feet;

(c) Beginning at a point 14 feet east of the edge of the paving of Alabama Highway 25, said point being 288 feet northeast of the intersection of Main Street and Alabama Highway 25; thence northeasterly along the east edge of the paving of Alabama Highway 25 a distance of 3,040 feet; thence 90° left and northwesterly a distance of 35 feet; thence 89° right and northeasterly along the west edge of the paving of Alabama Highway 25 a distance of 150 feet;

(d) Beginning at a point in the center of the north edge of intersection of McGowan Road and Cemetery Street; thence easterly along the north edge of McGowan Road a distance of 650 feet to a point of ending.

Section 2. The said sanitary sewers shall be constructed with the necessary manholes and connections and in accordance with full details, drawings, plans, surveys, and estimates prepared by Harry Hendon & Associates, Inc., engineers of Birmingham, Alabama, which have been placed on file in the office of the Town Clerk in the Town Hall at Wilsonville, Alabama, where property owners who may be affected by the said improvements may see and examine the same. The Mayor and Town Council do hereby adopt the said details, drawings, plans, surveys, and estimates. The said sewers and appurtenances are to be constructed of brick, concrete masonry, steel, vitrified clay and cast iron sewer pipe as shown or described in the said details, drawings, plans and specifications.

Section 3. The cost of constructing the improvements authorized herein shall be assessed and levied in fair proportion against the real estate hereinafter described lying within the district drained by the said sewers; provided, however, that the said assessments shall not exceed the total cost of the said improvements; and provided, further, that no assessment against any property shall exceed the increased value of such property by reason of the special benefits derived by such property from the said improvements. The lots and parcels of land against which the said assessments shall be levied are described as follows:
