
AN ORDINANCE TO AMEND THE CODE OF THE CITY OF WILSONVILLE, ALABAMA, 1958 AND PARTICULARLY SECTION L7 AND NEIGHBORHOOD 2A AND 2B OF SAID CODE AND ZONING MAP.


The public welfare requiring it and under authority granted by title 37, Chapter 16, section 779 of the 1940 Code of Alabama, be it ordained by the City Council of the City of Wilsonville, Alabama, as follows, to-wit:

That the Dode of Wilsonville, Alabama 1958, Section L7 and neighborhoods 2A and 2B inclusive, and the zoning as a part thereof is amended, changed and modified as follows:

That the area described as beginning at center line of Highway 25 and northern boundary of city limits, and extending east 210 feet to a point; thence running in a southerly direction parallel to Highwat 25 a distance of 1,584 feet to a point; thence in a westerly direction 560 feet to a point; thence in a northerly direction parallel to Highway 25 a distance of 1,584 feet to City Limits; thence east to point of beginning.

The above described area shall be shown and classified on said map as (B1) Business District subject to all rules set forth in L7 of said Code.


