

ORDINANCE No. ~~530~~ 53

TOWN OF WILSONVILLE, Alabama.

AN ORDINANCE TO PROTECT THE PUBLIC HEALTH AND TO PROVIDE FOR THE SAFE AND PROPER DISPOSAL OF HUMAN EXCRETA AND OTHER SEWAGE WASTES, THE INSTALLATION OF SANITARY WATER CLOSETS, SEPTIC TANKS, DISPOSAL FIELDS, SANITARY SEWERS, PIT PRIVIES OR DRY CLOSETS AND TO REGULATE THE TYPE, LOCATION, CAPACITY, CONSTRUCTION, MAINTENANCE AND USE OF THE SAME IN THE TOWN OF WILSONVILLE, Alabama, AND ITS POLICE JURISDICTION.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF WILSONVILLE, AS FOLLOWS:

Section 1: It shall be unlawful for any person, firm, corporation or their agent to construct, maintain, use or permit the use of any building, dwelling, shelter, premise or other place where human beings congregate, reside, work or rest within the TOWN of WILSONVILLE or its police jurisdiction, in which is not provided adequate facilities for the disposal, in a sanitary and proper manner, of all human excreta and other sewage wastes resulting from the control or use, for whatever purpose, of the said place.

Section 2: The County Board of Health of SHELBY County or its authorized representative is hereby empowered by TOWN of WILSONVILLE make inspections and investigations at any reasonable time on any place or premise within TOWN of WILSONVILLE, Alabama or its police jurisdiction and to take necessary legal action through the City to regulate and control the disposal of human excreta, and other sewage wastes in accordance with the regulations, specifications and requirements uniform and general set forth and approved by the State Board of Health and these regulations shall herewith become a part of this ordinance.

Section 3: At places located within the TOWN of WILSONVILLE or its police jurisdiction where adequate public sanitary sewers are available the disposal of human excreta or other sewage wastes shall be to said sanitary sewers and at places located where said sanitary sewers are not available disposal of human excreta or other sewage wastes shall be to a septic tank and disposal field as permitted by the SHELBY County Health Officer and no septic tank, disposal field or other means of disposal shall be constructed within TOWN of WILSONVILLE its police jurisdiction prior to the issuance of a permit by said County Health Officer to the owner of the place or premise to construct and use a private individual disposal system.

Section 4: All departments, agencies and offices of the TOWN of WILSONVILLE, Alabama and their representatives, agents and officers are hereby prohibited from issuing building permits or licenses to construct or build any building, dwelling, shelter, premise or other place in which there is or is likely to be a need for the sanitary and proper disposal of human excreta or other sewage waste except that when the applicant for such

building permits or licenses shall show evidence of his compliance with all other sections of this ordinance.

Section 5: The provision of this ordinance relating to sewer connections shall be deemed to apply where a public sanitary sewer is or becomes reasonably accessible. A public sewer shall be deemed reasonably accessible when said sewer is located within a distance of two hundred (200) feet of any outside line of the lot upon which such dwelling or other building is located, provided such sewer may be reached without having to cross the property of another. After such public sanitary sewage becomes available connection to said sanitary sewage shall be required within a period of 120 days.

Section 6: In case of failure of any person, firm, association, corporation, or their agent to comply with provisions of this ordinance within fifteen (15) days after being served with a written notice, the TOWN of WILSONVILLE, Alabama may order and execute the necessary improvements, the costs of same to be assessed against and to become a lien upon the entire property or premise upon which such installation or improvements are made in accordance with Title 37, Chapter 13, Section 606, of the Code of Alabama, Recompiled 1958.

Section 7: Each and every violation of the provisions of this ordinance shall constitute a separate offense for each day the violation exists.

Section 8: Any person, firm, corporation or agent found guilty of violating any of the provisions of this ordinance shall be fined not less than \$5.00 nor more than \$100 for each offense, and may also be sentenced to hard labor for not more than six months, one or both.

Section 9: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

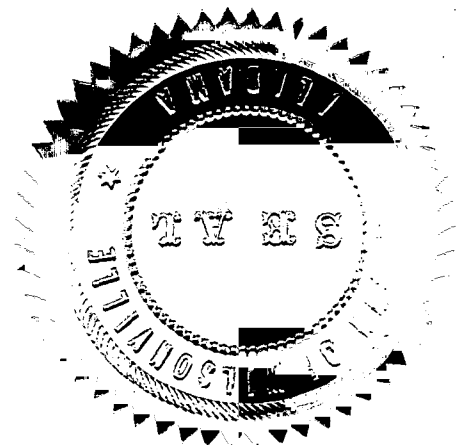
