

The Wilsonville Town Council met Tuesday, September 07, 2010, in the Council Chamber Room of the Wilsonville Town Hall. Mayor Rosemary Liveoak called the meeting to order at 6:30 P. M.

The meeting opened with prayer by Melissa Rosetta.

Mayor Liveoak reported plans for Whigmaleerie Day are complete. There are close to forty vendors coming with a variety of items, including food. The talent show has been eliminated because no one signed up. There are several signed up for the chili cook-off.

The 2011 budget was the next item on the agenda. Final copies of the budget were mailed to the council members; however, three of the members (Dennis Blackerby, Calvin Gill, and Lee McCarty) never received theirs. Mayor Liveoak pointed out a three per cent (3%) cost of living raise for employees is included in the budget. The following actions were taken:
