The Wilsonville Town Council met Monday, March 18, 2013, in the Council Chamber Room of the Wilsonville Town Hall. Mayor Lee McCarty called the meeting to order at 5:58 P. M.

The meeting opened with prayer by Chuck Webb, Wilsonville Baptist Church.

The following council members answered roll call: Dennis Blackerby, Don Davis, Calvin Gill, Patricia Johnson, Ricky Morris, Terry Newman, Alan Revis.

The minutes of the March 04, 2013, regular council meeting, mailed to the council members prior to the meeting, were reviewed. Patricia Johnson made a motion to correct the minutes as follows: page three, paragraph two, sentence three; remove the word "only". Terry Newman seconded, and the motion passed with the following vote; Dennis Blackerby, yes; Don Davis, yes; Calvin Gill, yes; Patricia Johnson, yes; Ricky Morris, yes; Terry Newman, yes; Alan Revis, yes. Ricky Morris made a motion to approve the minutes with the above mentioned correction; Calvin Gill seconded. The motion passed with the following vote: Dennis Blackerby, yes; Don Davis, yes; Calvin Gill, yes; Patricia Johnson, yes; Alan Revis, yes. The checks were reviewed by the council members. Patricia Johnson questioned expenditures made for park and recreation repair and maintenance. She said these expenditures were not cleared with the council ahead of time and should be. These are annual expenditures to prepare the parks for baseball season such as pressure washing and painting. There are funds included in the budget; however, they should be brought before the council beforehand for approval. Dennis Blackerby will handle the issue with the Park and Recreation Board and see that this procedure is followed in the future.

Mayor McCarty reported the roof has been replaced on the bank building. Terry Bell, Commercial Development Authority, reported he found a leak inside the building Saturday, after the job was completed, and he is not pleased with the way the flashing was done. Mayor McCarty will look into these issues.

The mayor stated the trees have been planted at Helms Park.

The dump truck purchase was addressed. Don Davis distributed appraisal information as did Mayor McCarty. Don Davis made a motion to purchase a 1998 Chevrolet 3500 HD dump truck from Ben King for \$10,000.00; Terry Newman seconded. The motion passed with the following vote: Dennis Blackerby, yes; Don Davis, yes; Calvin Gill, no; Patricia Johnson, no; Ricky Morris, yes; Terry Newman, yes; Alan Revis, yes.

Mayor McCarty asked the excess property (Ford F250 truck, Crown Victoria automobile) be sold as soon as possible.

Picnic tables at Helms Park were discussed. The mayor suggested two tables (one from each of the two small pavilions) at Oak Meadow Park be moved to Helms Park since they are not utilized much. Depending on the use of these two tables, a decision will be made whether or not to purchase more. Terry Newman stated more tables will be needed if there is a post season tournament at Helms Park.
