The Wilsonville Town Council met in regular session Monday, August 19, 2013, in the Council Chamber Room at the Wilsonville Town Hall. Mayor Lee McCarty called the meeting to order at 6:00 P. M.

The meeting was opened with prayer by Reverend Glenn Wilson.

The following council members answered roll call: Don Davis, Calvin Gill, Patricia Johnson, Ricky Morris, Terry Newman, Alan Revis. Dennis Blackerby was not present.

The minutes of the August 05, 2013, regular council meeting (mailed to council members prior to the meeting) were reviewed. Terry Newman made a motion to accept the minutes, as presented; Ricky Morris seconded. The motion passed with the following vote: Don Davis, yes; Calvin Gill, yes; Patricia Johnson, yes; Ricky Morris, yes; Terry Newman, yes; Alan Revis, yes.

Council members viewed outgoing checks immediately before the meeting. Alan Revis made a motion to send the checks out; Patricia Johnson seconded. The motion passed with the following vote: Don Davis, yes; Calvin Gill, yes; Patricia Johnson, yes; Ricky Morris, yes; Terry Newman, yes; Alan Revis, yes.

V Adams, Waste Pro representative, went over the proposed contract for garbage pick-up in Wilsonville. Waste Pro won the bid for the Shelby County contract on which we are "piggy-backed". Their rates are: Standard service, \$11.65 for one can, \$19.00 for two cans; recycling every other week at no extra charge; bulk pick-up (leaves, limbs, etc.), \$23.00 (this service may not be included on our contract).

Dennis Blackerby arrived at 6:05 P. M.

Ms. Adams stated the new service will begin October 01, 2013. Post cards will be mailed to all Wilsonville customers to sign up for the recycling benefit so Waste Pro can deliver those cans.

Mayor McCarty suggested budget workshop sessions be held beginning at 5:30 P. M., immediately prior to the regular council meetings in September and that the first meeting in September be held September 9 (the second Monday of the month), due to the Labor Day Holiday. Terry Newman made a motion to hold the first regular meeting in September on September 9 and budget workshop sessions be held beginning at 5:30 P. M. September 9 and September 23, 2013, preceding the regular council meetings. Patricia Johnson seconded the motion which passed with the following vote: Dennis Blackerby, yes; Don Davis, yes; Calvin Gill, yes; Patricia Johnson, yes; Ricky Morris, yes; Terry Newman, yes; Alan Revis, yes.

There were no requests.

Council Comment

Don Davis asked Richard Atchison (Commercial Development Authority member) the status of getting a bank in town. Mr. Atchison stated there is no progress yet.

Mayor McCarty reported on the meeting he attended concerning the school resource officer for Wilsonville Elementary School. Attending the meeting, in addition to Mayor McCarty, were a representative of the Shelby County Board of Education, Shelby County Commission, and Shelby County

Sheriff's Office. The Town will receive \$8,000.00 to go toward funding for an officer. If the Town hires half a deputy, the total cost will be \$40,000.00, and when school is not in session, he or she can do a four hour shift where needed. The consensus of opinion of the council is the Town should not have to bear any of the expense; it should be the responsibility of the Shelby County Commission since the school is not a city school but a county school. It was stated the Commission has funds in reserve which could be used for this purpose. Although all are in agreement with this, there seems to be no way around the Town bearing the expense.
