

The Wilsonville Town Council met Monday, November 3, 2014, in the Council Chamber Room at the Wilsonville Town Hall. The meeting was called to order by Mayor Lee McCarty at 6:00 P. M.

The meeting was opened with prayer by Councilman Calvin Gill.

The following council members answered roll call: Dennis Blackerby, Don Davis, Calvin Gill, Patricia Johnson, Ricky Morris, Terry Newman, Alan Revis.

The minutes of the October 20, 2014, regular meeting, mailed to the council members prior to the meeting were reviewed. Calvin Gill made a motion to accept the minutes, as presented; Patricia Johnson seconded. The motion passed with the following vote: Dennis Blackerby, abstain; Don Davis, yes; Calvin Gill, yes; Patricia Johnson, yes; Ricky Morris, yes; Terry Newman, abstain; Alan Revis, yes.

Treasurer Don Davis presented the treasurer's report for the month of October as follows:

Mayor McCarty stated he plans to move the water works loan to SouthPoint Bank soon.

Outgoing checks were examined by the council members immediately before the meeting. Don Davis made a motion to approve the checks for mailing; Ricky Morris seconded. The motion passed with the following vote: Dennis Blackerby, yes; Don Davis, yes; Calvin Gill, yes; Patricia Johnson, yes; Terry Newman, yes; Alan Revis, yes.

The Town Clerk introduced Samantha St. John, chief financial officer of ClasTran. Ms. St. John stated ClasTran operates with a combination of federal grants and matching money. There are two grants involved, one for urban areas and one for rural areas. ClasTran provided transportation at a charge of \$4.00 each way, Monday through Friday from 6:00 A. M. until 7:00 P. M., for those who otherwise would not have a way to go. They pick up clients at their residences. They make a lot of trips to senior citizen centers and a lot of trips for medical reasons. She is asking the Town to donate \$954.00 this year. For every \$1,000.00 donated, they receive \$4,000.00 in grant funds. ClasTran provides approximately seven- hundred rides a day.

#### Mayoral Announcements

The mayor reminded everyone to go to the polls and vote tomorrow. Polls will be opened from 7:00 A. M. to 7:00 P. M.

Mayor McCarty asked Roger Perry to report on the progress of the Highway 25 project. He stated there have been a few times when one lane traffic has extended past 3:00 P. M. The next phase will involve moving water lines between Paul's Shell and McGowan Road. Sewer lines have already been moved, and the water lines will not take as much time as that did. The road will be closed to all traffic one weekend from 6:00 P. M. Friday to 6:00 A. M. Monday. When the dates are set, the Town will be notified at least forty-eight hours in advance. Probably the earliest this will occur will be the weekend of November 15<sup>th</sup> and 16<sup>th</sup>. The mayor asked if the information could be put on the new sign at the Wilsonville Baptist Church when it becomes available; Patricia Johnson will check on this. Improvement work has been done on the drainage ditch behind Paul's Shell at Town expense. Alan Revis asked if the ditch running beside Highway 25 will still be there at the completion of the project. The mayor stated a ditch will be there but will be farther from the road than it is now. He plans for the Beautification Board to do some planting of trees between the road and the ditch when the road work is complete.

Town Clerk Kay Ray read a thank you letter from the Wilsonville Elementary School for the \$3,000.00 donation from the Town.

The town clerk reported on the October 30, 2014, Planning and Zoning Board meeting at which the board voted to recommend approval of a request for changing the zoning on a parcel of property located on Carlson Road from Holding Zone District to Agricultural District. There is a planned group home for young autistic adults. The property was placed in the Holding Zone District due to its proximity to the proposed route of Highway 145; however, the completion of Highway 145 seems to be nonexistent now. The property was formerly zoned Agricultural, and there was an assisted living facility there. The council will need to address the issue at the November 17, 2014, meeting.

#### Council Agenda

Don Davis asked that garbage charges be addressed, specifically the issue of charging a penalty fee for customers whose garbage cans are picked up for nonpayment when the delinquent bill is paid and the can is returned to the customer.

#### Council Comment

There was none.

#### Public Comment

There was none.

There being no further business to come before the council, Don Davis made a motion to adjourn; Ricky Morris seconded. The motion received unanimous approval.

The meeting was adjourned at 6:51 P. M.
