The Wilsonville Town Council met Monday, December 01, 2014, in the Council Chamber Room at the Wilsonville Town Hall. Mayor Lee McCarty called the meeting to order at 6:00 P. M.

The meeting was opened with prayer by Councilman Calvin Gill.

The following council members answered roll call: Don Davis, Calvin Gill, Patricia Johnson, Terry Newman, Alan Revis. Dennis Blackerby and Ricky Morris were not present.

The minutes of the November 17, 2014, regular council meeting (mailed to council members prior to the meeting), were reviewed. Don Davis made a motion to accept the minutes, as presented; Calvin Gill seconded. The motion passed with the following vote: Don Davis, yes; Calvin Gill, yes; Patricia Johnson, yes; Terry Newman, yes; Alan Revis, yes.

The treasurer's report for the month of November was presented by Councilman Don Davis, as follows:

Mayoral Announcements

There was a robbery at Jerry's Bait and Tackle Saturday night. A gun was involved, money was taken, and no-one was injured.

There will be a meeting of the Wilsonville Zoning Board, Thursday, January 08, 2015, 7:00 P. M., to discuss amending the Zoning Ordinance to either disallow or restrict modular housing in the E-1 and E-2 Zoning Districts in the future.

The second regular council meeting for January will fall on Martin Luther King Day. The mayor asked the meeting be rescheduled for the following night. Patricia Johnson made a motion the second regular council in January be held Tuesday, January 20, 2015; Calvin Gill seconded. The motion passed with the following vote: Don Davis, yes; Calvin Gill, yes; Patricia Johnson, yes; Terry Newman, yes; Alan Revis, yes.

The Highway 25 project is going well. There have been a couple of injuries and water line glitches. The road will be closed from 12:01 A. M., December 6 until 12:00 midnight, December 7 in order to replace a culvert near McGowan Road. Lane Ross asked if the project was going to involve anything on Highway 25 South. The mayor replied there will be a turn lane added at the traffic light on that side, but that will probably be the last thing done. Roger Perry stated the work at the traffic light will be an end of the project item. There will be manholes replaced as well as some very old cast iron water lines which will be replaced with ductile iron lines.

The garbage reinstatement fee was discussed. This is a fee to be charged to garbage only customers who have their cans picked up due to nonpayment. In order to restore service, the fee would have to be paid. After some discussion, Don Davis made a motion to set the fee at \$24.00; Patricia Johnson seconded. The motion passed with the following vote: Don Davis, yes; Calvin Gill, yes; Patricia Johnson, yes; Terry Newman, yes; Alan Revis, yes. An amendment will be prepared for the appropriate ordinance and will be presented at the next meeting.

The mayor reported he met with ALDOT officials Wednesday, November 26, to discuss the ongoing road project and a proposed project to pave, widen the shoulders, add reflective lane markers and restripe Highway 25 from Columbiana to Highway 61 in Wilsonville. He asked about the possibility of replacing the narrow bridge on Highway 25 at the same time. The bridge, though narrow, is structurally sound, and therefore, not a candidate for replacement. The officials stated, if the Town could get some matching funds, there might be a possibility, but otherwise, it is not going to happen. The estimated cost for replacement is two-million dollars. There would need to be at lease fifty per cent matching funds from somewhere.

Resolution 141201-1 to approve the paving project from Columbiana to Highway 61 in Wilsonville was introduced as follows:

WHEREAS, the same citizens are scheduled to have a work session with the Planning and Zoning Board to discuss options regarding limitations of the specific type of modular construction within said district on January 8, 2015; and,

WHEREAS, should the Planning and Zoning Board consider amendments to the E-1 and E-2 Zoning Districts proper notice and a public hearing shall be held prior to consideration of adoption of any such changes;

WHEREAS, the duration of this moratorium shall be one year from the date of its adoption to allow adequate time for consideration of the request, notification and public hearings regarding any proposed changes;

- (2) And to perform all acts and execute and deliver all instruments which the Bank may deem necessary to carry out the purposes of this Resolution.

RESOLVED FURTHER, that this obligation is a general obligation and the full faith and credit of the Town are pledged to the payment of the principal of and interest on the obligation.

RESOLVED FURTHER, that the note or other evidence of indebtedness executed pursuant to this Resolution will be paid only to the named owner, or its registered assigns as shown on the note or other evidence of indebtedness and on the books of the Town maintained for that purpose by the Treasurer as registrar, and that the note or other evidence of indebtedness is or will be a "qualified tax-exempt obligation" for federal income tax purposes, and that the Town covenants to comply with the federal tax law requirements, including the filing of information returns and other documents necessary to establish tax-exempt status.
