### Mayoral Announcements

Most of the water meters have been installed. There is still some clean up to do and data needs to be put into the computer. Roger is working on getting the data transferred so meters can be read.

The mayor is still getting compliments on the new park. We still owe about \$28,000.00 but this will not be paid until some issues are cleared up.

There is one more glitch in the sidewalk project. There is a utility pole that will have to be moved. Alabama Power Company was approached and agreed to move the pole; however, the pole is not a Power Company pole. It is a telephone pole. AT&T will be contacted about relocating the pole.

Everything is set for God and Country. The mayor has talked with the peach provider and will call him Wednesday to get a firm price. The peaches will be picked up on Saturday. If it rains Sunday, the program will be moved to the gym at the Baptist Church and food will be served from the kitchen at the church.

The Oakland Avenue concrete project may be piggybacked with a Shelby County Park project if Clay Adderholt can arrange it. This may be the best thing for us. We are having difficulty getting someone to spec out the job for bidding, and this could solve that problem.

Mr. Cosby was unable to find Bermuda grass which was included in the original bid and had to substitute Emerald Zoysia. There is a price difference of \$6,300.00 for this substitution. Don Davis made a motion to pay the \$6,300.00 difference; Patricia Johnson seconded.
