Pam Greene reported the Mobile Pantry Food Distribution will be Tuesday, September 15, from 11:00 A. M. until 1:00 P. M., at the Gazebo Parking Lot. The food is donated by the Food Bank of Alabama and is distributed on a first come, first serve basis. No proof of need is required. She has volunteers lined up to work, signage is coming, cones and a pallet truck will be needed. The truck should arrive by 9:00 A. M. From 9:00 to 10:00 A. M., the truck will be unloaded and boxes of food assembled for give away. There will be a census kiosk at the exit. We expect to have 200 boxes for distribution. This will occur every third Tuesday for the months of October (20), November (17), and December (15) and may continue depending on the turnout we have. The cost of banners is \$180.00; signs is \$240.00

Mavis Cohill reported the Country Kitchen BBQ food truck is continuing to come to town. Also, a pizza truck and an ice cream truck are coming on Thursdays. The ice cream truck will stay until 2:30 P. M. She thanked Richard Atchison for finding the pizza and ice cream trucks. Mavis is working on getting some evening hours for the food trucks. Mayor McCarty said maybe the word will get out in the food community and help us get a brick and mortar restaurant to locate here. The mayor has not heard anything else from Joe's Italian.

## **Mayoral Announcements**

The mayor has a meeting scheduled with ALDOT, September 24. The Highway 25 bridge and the sidewalk project are ongoing. The bridge is close to completion.

Councilman Fluker had mentioned having a brainstorming meeting with the elected officials to make a list of future plans and prioritize. Mayor McCarty asked if he would like to make that a part of the first council meeting in October. No such meeting can be held without advertising and being open to the public, according to Alabama law. This will be an agenda item for that meeting.

Roger Perry, who will be retiring, in a couple of years. Right now, our system requires a Grade 2 certified operator; however ADEM is in the process of changing some of the regulations and this may change.
